Jack Houseal presented the 2009 Audit Report to the Board.

Motion 2010-0056 – Allen Massey made a Motion to approve the adult tennis fundraiser, Ace out Cancer (*see attached*) on November 13, 2010 as presented by Adam Regelsky. **Approved Unanimously.**

Motion 2010-0057– Jim Bitner made a Motion to approve the Legacy Park Networking Group (see attached) as proposed by Abdi Aslani. **Approved 3-1 with Mary Ellen Tulper voting no.**

Danny Orlando, Regional Energy Star Program Manager at the EPA, made a presentation on behalf of Energy Star and holding an event in Legacy Park to inform residents about energy efficiency. The Board approved the proposal and Danny will work with the HOA office to get an event scheduled for Legacy Park.

The Board discussed the clubhouse usage as a polling facility and agreed that candidates' signs may stay on common property the day of the election only.

- After 4 weeks most submit application (Subject to Approval)
- Only One Type member/industry allowed per paid membership
- Members most attend ever week or have a replacement.
- No Show 3 times in 6 months subject to termination of membership.

All Members contribution is tracked & General Group progress (ie, revenue generated, referral passed) is also tracked and shared weekly @ the meeting.

- Danny attended Georgia Tech and graduated as an Industrial and Systems Engineer with honor.
- He has been at the EPA in the Atlanta Regional Office for nearly 20 years. For 18 of those years, Danny has served as the Regional Program Manager for ENERGY STAR and a technical contact for Climate Change.
- Danny is part of the 'energy team' that qualified the Atlanta Federal Center, the 9th largest Federal Building in the country at 2.4 million square feet, as an ENERGY STAR building.
- Danny has been featured in many news programs, radio and television spots, and publications over the years. The most distributed piece was the movie *Kilowatt Ours* which was seen by 65 million viewers. Danny has also appeared in segments with Clark Howard on WSBTV.
- As you will see, Danny is passionate about energy efficiency and the planet we all share. For example, his business cards are not only made from 100% post consumer recycled paper, but also contain 10% coffee agricultural waste. So make sure you get one and if times get rough you can make a weak cup of coffee.
- Danny isn't afraid to crawl around a house looking for air leaks. Retrofits on his 1984 home have resulted in a 32% energy reduction or a savings of about \$450/year. His home qualified as ENERGY STAR in 2005.
- Danny is also the *contemporary service* worship leader at Kennesaw United Methodist Church. He leads a 5-piece top-40 Christian band (*Crossroads*) as the lead acoustic rhythm guitarist and lead singer. He has held this position for the past 7 years.
