Welcome to Legacy Park's 2015 annual meeting!

The number one goal of the HOA is preserving our property values. The HOA employees 6 staff members to help attain this goal. As our community transitions to the 20 year old mark, taking care of the common property is more important than ever. It is the responsibility of the HOA to ensure that funds are allocated each year to do this and it is done during the budgeting process, and all owners are welcomed to assist. Watch for information in August about getting involved.

Collection of assessments is a vital part of this process. We work diligently to get the funds collected. We work with our residents as much as we can; however, we do resort to collection attorneys. If you don't pay your dues, we not only file liens against properties, we file lawsuits. When a judgment is issued against an owner, it becomes their personal debt and follows you until it's satisfied, even in cases of foreclosures. While, we want to be friendly and neighborly, at the end of the day it's a business and our community depends on the collection of assessments.

It is the homeowner's responsibility to take care of their individual home. We often have varying opinions on how this is done, but by looking at the community overall, the majority of people are doing their share. Of course, not everyone does, which is why Joanne's job is always challenging. She has been doing this for over 10 years now, and while so much of her job is interacting with residents, we have quantified this position as much as possible to give you an idea of the territory she covers. In 2014, we opened 3,500 cases and closed 3,800.

We have a part time assistant to work on the leased properties in Legacy Park. We have 208 rental properties or 12%, this number is up 2 houses from this time last year. Of these, 47 (up 10 from 2014) are owned by corporations, which add an extra challenge with the many levels of communication. The lease fees collected by the HOA cover the cost of this position. The covenant enforcement on these properties is done the same as all other 1,537 homes in the community, with the exception on ensuring all documentation is on file as set by the Rules.

The fun part of the HOA is led by Trasey Welton. Trasey has been our Activities Director for 8 years and she is busy fine-tuning the 2015 Events Calendar. The 1st event for this year is of Girl's Night Out which this Thursday at Henrys. Join the Legacy Park ladies at 7pm, no tickets required, but Trasey does need a head count, so send her an email if you plan to attend.

On May 9th, our first concert headlines the Tyler Hammond Band, which is an up and coming country band and we will have a bbq vendor. Food trucks will be visiting us one night a week in the spring at the amphitheater and we are working on bringing the Farmer's Market back to Legacy Park. Trasey is working on the details which will be in the upcoming newsletters. Trasey is also working on finalizing the details for the July 4th and Picnic in the Park events that both include a great fireworks show. Tom King is working with Trasey in starting up an Activities Club and has a signup sheet. Please stop by and leave your contact information. This is a great way to be involved in the community and have some fun!

Sara Jane Gallo is our sports coordinator. Sara does a great job in communicating information about all of our sports and working with volunteers who organize the sports. All of these sports would not happen if it wasn't for the volunteers who step up every year. Thank you!

Probably the most thankless job is serving on the Board of Directors. While it would be logistically impossible for the community to vote on every decision that needs to be made in Legacy Park, we elect the 5 volunteers who we think will best serve our interests. They spend a countless number of hours for the betterment of this community. While they do what they believe is in the best interest of the overall community, they are typically criticized more frequently than thanked. They all take pride in being transparent with their decisions and their availability to answer any questions residents may have. I urge you to introduce yourself and thank them for volunteering their time and lending their talents and insight to Legacy Park.

We also have many committees of volunteers that continually work to make Legacy Park great place for all of us. We have an active Architectural Review Committee, Covenants Appeals Committee, Active Adults 55+ Group, Cub Scouts, Boy Scouts, Election Committee, Finance Committee, Youth and Adult soccer coordinators and coaches, Baseball coordinators and coaches and the Swim Team coordinators. It is volunteers like this that make Legacy Park thrive. Thank you to all of you who invest your time and energy!

Everyone who is at least 55 is invited to a free luncheon sponsored by the active adults 55+ club. Luncheon date is Wednesday March 11, at 12:00, at the clubhouse. After lunch the group will socialize by playing cards and other board games. No pressure to become a member, just to have an afternoon of fun. Please contact Tom King for more information about the club.

Without going through the entire list of items done in 2014 and planned for 2015, the most notable are: a new sand volleyball court; new backboards and goals at the basketball court; painting all the pool houses and bridges; recoating 4 tennis courts and the basketball court; resurfacing the Lullwater pool and a new pool cover on that pool.

This year we are adding electronic card access to the main pool. Please make sure you have the correct amenity card to get into the pool this year. If in doubt, call or email us.

A long term project that we are starting this year is **replacing the traffic signage poles.** We are starting with the entrances and will progress throughout the community for the next 7 years. We are working closely with the city of Kennesaw to ensure that we meet all the Federal regulations which requires the bottom of the stop sign be at 7'. Over all, this is a \$165,000 project.

We need is involvement from residents. It takes a community of people to make Legacy Park great. We hire security guards to monitor the amenities, as the HOA has no authority to protect any person or any home in Legacy Park. If you see something that is suspicious, call the Kennesaw Police. Calling the HOA after the fact does very little to rectify the problem.

Communication always comes up during the election time. We do not host an open-message board on social media pages. We do host a Legacy Park Facebook page for information only. We also send out email blasts and monthly newsletters. If you do not receive these emails from us, please sign up on our website. If you have any ideas of other forms of communication, we would love to hear those.

If you ever have any questions about the HOA, please call us, email us or stop by the office. We will help you with any concern you have about the HOA, from reviewing financial documents to signing up for a committee. With a community our size, there are many areas where volunteers are needed, **take the opportunity to make your community better.**

Election Results: 2015 Legacy Park Directors Election Ballot

The election was conducted from 12:01 AM, January 27, 2015 to 6 PM (EST), February 13, 2015. There were 333 total voters who submitted a ballot. 12 of these ballots were not counted because they were submitted by members who were delinquent in HOA fee payment. The final 321 valid ballots amounted to a participation rate of 18.4% of the 1745 total codes issued. A total of 290 ballots (90% of total submitted) were cast electronically, while 31 paper ballots were mailed to Vote-now. The results are as follows:
