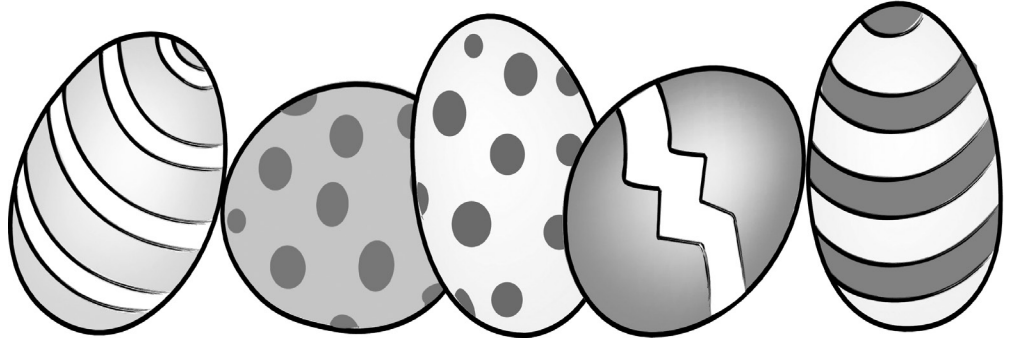

HOA News & Information

Reviewing information from last winter, it looks like we've had a repeat in weather, what another wet and dreary season! More rain this winter has brought on some unplanned work for the HOA and the City of Kennesaw. With the creek winding through our common property, the trails have once again taken a hit as well as some creek bank erosion. We are working on getting the damaged trails repaired and top-dressing trails that weren't damaged but need some sprucing up.

Planning for the 2020 pool season is well underway. The renovation to the Main Pool pump room is nearly complete and we have contracted to have the Quiet Pool and Mushroom resurfaced. The Winterthur Pool will have a card access gate added this year, so the only code access you will need is for the Winterthur Pool bathrooms. New garbage cans are ordered for the Lullwater and Winterthur pools that will look great with the pool furniture!

As you have all seen, the work on the lake fountain has taken longer than anyone expected. The fountain has been removed and is getting a tune up, new power cords and will come back "beaver" proofed. With the issues caused by the beavers and otters that have made the lake their home, we are working on getting the population under control and the beaver dam removed. Unfortunately, all the rain has prohibited our contractor from getting the dam removed. We plan to put grass carp in the lake to control the grass weed that grew last year. We will monitor the otter situation and may revisit the way we take care of the grass weed. Thank you for your patience with this!

LATE ANNUAL ASSESSMENTS

2020 Annual Assessments were due on January 1st and considered late after January 31st. If you haven't paid your assessments, you should have received a notice informing you that a 10% penalty was added to your account and your amenity privileges have been revoked. Please help us avoid additional time and expense – for you and the HOA – by making that payment now!

REMEMBER – if you owe money to the Legacy Park HOA, you and your family cannot participate in any of the activities that take place on Legacy Park property such as, playing tennis, participating in one of the many youth sports leagues, use the fitness center, use of any of the great amenities (playgrounds, pools, basketball court, baseball field, tennis courts, disc golf, amphitheater, bandstand, town green....) and rental of the clubhouse.

~ Don't forget ~ you can pay your assessments on-line through the Legacy Park website or through Buildium by credit card. Even though there is a processing fee(\$20 with Paypal, 2.95% with Buildium) charge to use the service, it is much less expensive than the attorney's fees and interest charges!

2020 SPRING MAIL-OUT

It's hard to believe, but yes, spring is just around the corner and so is pool season. The pools are tentatively scheduled to open on Saturday, May 2nd. As a rule of thumb, the pools open the first weekend in May each year. Remember all pools now have an electronic access gate, so make sure you get a new ID if you don't already have a card with access! If the back of your card has a serial number on the bottom, you have an electronic card. If in doubt, call, email or stop by the office so we can verify this for you. Please remember that replacement ids are \$10.

During the month of March, the HOA office will send out 2020 amenity stickers to homeowners who have a zero balance on their account, i.e., no outstanding assessments, fees or fines. This mail-out will be sent via first class mail and will go directly to the owner on record. If you are a renter, you will need to contact the homeowner.

WHO HAS A DRAINAGE ISSUE?

With all the rain we have had recently, drainage issues have been appearing throughout the community. The HOA continues to address issues on the common property and Hutcheson keeps our culverts clear. After the significant rain in February, they were out cleaning up the debris the next day, repairing hazardous areas of the trails, clearing culverts for the rain to come and clearing all the debris from under the bridges. This is a never-ending task, as there are all sorts of debris that ends up in storm drains besides leaves and branches, we have found pieces of plywood, lawn furniture, tires, and all sorts of trash. Please be aware of what you leave in your yard, it will end up elsewhere and sometimes can cause some significant problems.

There are many stormwater drainage areas that run between the private properties in Legacy Park and at the back of homeowner's lots. These areas are normally owned by the individual homeowner, which means it is the homeowner's responsibility to keep clean. Each homeowner should refer to the plat of their property for further clarification. If your plat does not indicate you adjoin common property, the HOA is not responsible for the area. However, if you have some type of permanent drainage structure on your property, then you should contact the City of Kennesaw Storm Water Management for further clarification.

Generally, this is an owner-to-owner issue for which the Association has no responsibility or obligation to address. The HOA can't see the backyard of all the homes, but your next-door neighbor usually can. Legacy Park Rules and Regulations provide that rear yards may be sodded, seeded or treated naturally but must be kept tidy and not have a negative impact on adjacent property owners. All property owners are required to provide regular landscape maintenance of their yards.

Please take some time to look at the accumulation of limbs, leaves, trash, etc., that may be at the back of your yard and develop a plan to get it cleaned up. If your backyard is fenced, make sure any area behind the fence that is yours is cleaned up. The owners who live at the mid and lower points of the streets, are having some real issues with the water runoff and the debris that is in your yard may be causing some of these problems. Be a good neighbor and don't let items in your yard end up in someone else's yard.

Financial Update

In order to fund expenses for maintenance and upgrades of Legacy Park, annual assessments must be levied against each property. Our yearly budget is prepared based on the receipt of these assessments from all homeowners. If the assessments are not received, our financial position is impacted.

According to our records as of February 13, 2020 the following balances remain outstanding with the HOA. These are cumulative balances, not just 2019 outstanding assessments, i.e., includes owners who have had balances for years. This information is being provided to keep our members informed of the financial status of the association.

SAFETY HAS TO BE THE #1 PRIORITY

Spring sports have started again in Legacy Park and the circle will be especially crowded on Saturday mornings! Please follow the guidelines below when parking along the circle within Legacy Park. Failure to do so could result in ticketing and or towing by the City of Kennesaw.

- Only park on the INSIDE of the circle
- Only park WITH the flow of traffic
- Do not park within 30' of an intersection – IT'S ILLEGAL AND DANGEROUS. As a reminder, the HOA has painted curbs white at intersections and loading and unloading zones and have installed no parking signs.
- Do NOT park in front of the fire hydrants.

Parking on the grass or the Town Green is prohibited, as is driving onto the gravel trails!

Legacy Park Guest Policy

When bringing your friends to the amenities, keep in mind the guest policy:

- Up to four (4) guests will be allowed per resident over the age of 18 for use of the Trails, Town Green, Playgrounds, Amphitheater, Bandstand, and Baseball Field.
- Up to two (2) guests will be allowed per resident over the age of 18 for the use of the Swimming Pools, Tennis Courts, Volleyball Court and Basketball Court.
- Unaccompanied children between the ages of 12 and 18 are allowed only one (1) guest while on LP property and when using the amenities.
- Guests are considered to be non-LP residents. LP residents that have had their privileges revoked cannot come as a guest of another resident.
- A LP resident must accompany guests while on the common properties or while using any of the amenities. Long term guests (persons visiting for more than two weeks) may obtain a guest pass from the HOA office. As a reminder, homeowners are responsible for ensuring that their guests are informed of the rules of LP and that these guests follow the rules at all times. The LP HOA reserves the right to suspend privileges or prosecute an individual, resident or guest, for destruction, abuse or misuse of property.

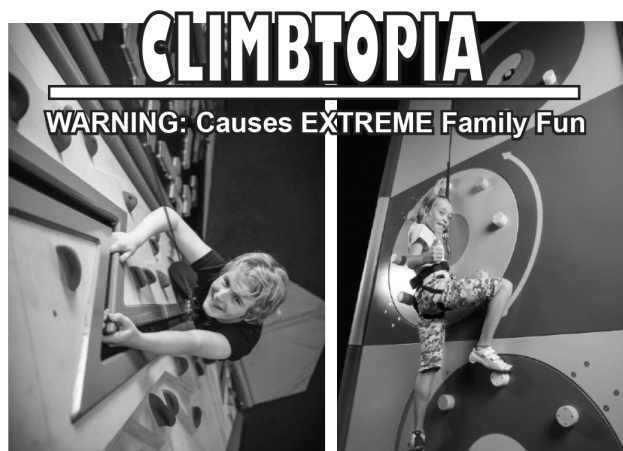

Competitors: Advanced Beginner Skills with very little issues starting the point with serves and returns. Green dot/low compression balls.

Upper Echelon: Year-round motivated tennis players. These players have State and/or Sectional Rankings that play at the high school level with college play in their cross-hairs. Regular balls, typical ages 13-18.

Echelon: Intermediate to advanced skills. Have skilled strokes with thought out point production patterns in their arsenal. Regular balls. Ages vary.

Futures: Intro to beginner level stroke production to be utilized for rally and serving. Orange/low compression balls. 25" racquets. Ages 7-10.

Youngsters: Taught basic skills and rules of the game. Red/Orange balls. Use 21"-23" racquets on 36' court. Ages 5-7.

Starting with Summer 2020, dues are due 2 weeks before the start of the league play within the season, for example, Junior Summer League starts 5/9, so each player would need to be paid in full by April 25th. The cost is \$50 /Resident Adult and \$25/Resident Junior. Or, if it is more favorable, there is a family plan available for \$110. Please pay online at www.legacypark.org or drop a check at the office. If you'd like to have your tennis dues added to your account through Buildium, so you can pay online, please contact the office. We're happy to do anything that makes this process easier! In addition, as a resident, you must be in good standing to play or have use to any amenity within Legacy Park.
