Welcome to Legacy Park's 2020 annual meeting!

The number one goal of the HOA is preserving our property values. The HOA employees 6 staff members to help attain this goal. As our community transitions to the 25-year-old mark, taking care of our homes and the common property is more important than ever. It is our responsibility to ensure that funds are allocated each year to do this and it is done during the budgeting process. Owners are welcomed to participate and provide input during the planning stages. Watch for information in August about getting involved.

2019 was a banner year for the community in catching up on projects and focusing a lot of attention on updating our aging landscape by taking care of dead and dying grass, and overgrown trees. As you can imagine, with a property our size and the challenges with everchanging weather conditions, this is always an important on-going focus. In addition to landscaping, the pools got a lot of much-needed attention, as did all of our other structures.

In 2020, the majority of the projects are focused on-going maintenance and improvements to the tennis courts, pools, the lake, and playgrounds. We have budgeted to continue with some landscape enhancements as well, such as the Kentmere Playground, Town Green Portal Entrance and the Main Pool Circle entrance. With the recent weather we've had, we will be doing some significant repairs to the trails.

Probably the most thankless job is volunteering to serve on the Board of Directors. While it would be logistically impossible for the community to vote on every decision that needs to be made in Legacy Park, **we elect the 5 volunteers who we think will best serve our interests**. They spend a countless number of hours for the betterment of our community. While they do what they believe is in the best interest of the overall community, **they are typically criticized more frequently than thanked**. I urge you to introduce yourself and thank them for volunteering their time and lending their talents and insight to Legacy Park.

We also have many committees of volunteers that continually work to make Legacy Park great place for all of us. **We have an active** Architectural Review Committee, Covenants Appeals Committee, Active Adults 55+ Group, Cub Scouts, Boy Scouts, Election Committee, Finance Committee, Landscape Committee, and Welcome Committee. And many sports groups, Tennis Committee, Youth and Adult soccer coordinators and coaches, Baseball coaches and the Swim Team coordinators. **It is volunteers like this that make Legacy Park thrive**.
