## HOA News & Information

### 2021 BOARD ELECTION DETAILS

The Board of Directors is utilizing the same election process for 2021 as we have since 2013. The election will <u>not</u> be held at the 2021 Annual Membership Meeting. Instead, homeowners will have the convenience of voting in the comfort of their own homes *electronically* or by *mail-in ballot* during an open voting period from February 1, 2021 to February 19, 2021. The Election results will be announced at the virtual Annual Membership Meeting on Tuesday, February 23, 2020. You will receive an email with the meeting link and it will be posted on www.legacypark.org.

The HOA has hired Vote-Now (a/k/a Campus-Vote.com) to manage the election process. Each property in Legacy Park will receive their voting package from Vote-Now prior to the opening of the voting period.

If we do not have an email address for you, you will receive your package via USPS in an envelope clearly marked with "Legacy Park Election Materials Enclosed". It will include a paper ballot that has your unique, secure household personal identification number (PIN) printed on it.

For those of you that we have an email address for, you will receive your package electronically. Any owner can vote electronically, all you need is your PIN and a computer with internet connection. Vote-Now will communicate through emails to those owners who have not voted, but your email address is NOT required in order for you to vote electronically.

Neither the Board of Directors, Election Committee nor HOA staff members will be involved in the collection or counting of any of the votes cast. Vote-Now is responsible for this process. In your voting package, you will receive all contact information if you have questions about casting your vote.

We look forward to continuing our more streamlined process during this election and hope that you find this to be a very efficient and effective way to cast your vote.

### DO YOU HAVE A GRADUATING SENIOR THIS YEAR?

Legacy Park is a great community for families and what better

way to honor our children who have achieved a memorable time in their lives than to highlight their achievement in the newsletter. In the May newsletter, we will include space to honor our residents who



will be graduating from high school or college. You will need to fill out the form found at www.legacypark.org. By completing this form, your graduate will also get a sign that will line Legacy Park Boulevard in May.

### **ELECTION REMINDERS**

During the election process, please remember that the HOA does **not** endorse any candidate(s). The HOA handles the official communication of election details to residents, along with Vote-Now. This specific process allows the residents to have all the information that has been submitted by all the candidates before they cast a vote. Other information may be sent by the individual candidates.

The official communication includes:

- Correspondence on LP HOA letterhead;
- The Legacy Park Town Herald newsletter;
- Legacy Park website;
- Legacy Park Community Association Facebook page (@legacyparkhoa); and
- Legacy Park e-mail distribution from the property manager and/ or Vote Now.

These communication tools are controlled and maintained by the Legacy Park HOA. The HOA does <u>not</u> maintain or control any social media discussion boards, <u>except</u> for one Facebook page named "Legacy Park Community Association".

It is not a violation of the Association's governing documents for members (homeowners) to campaign for Board positions or to go door to door.

If you want to guarantee how your vote is counted, you must complete and sign your Ballot or vote electronically for the directors you choose. The Ballot mailed to you includes all possible candidates through the date of the mail-out.

### ANNUAL ASSESSMENTS & FEES DUE JANUARY 31ST

The bill for 2021 annual assessments were mailed out in December and were payable by January 31st. If you have not paid your assessments, you will be receiving a late notice via email or in the mail (if we don't have your email address) with a late fee added to your account. Each month that your assessments go unpaid, interest will accrue on your assessment balance.

The 2021 amenity stickers for your Legacy Park ID will be mailed to homeowners who have a zero balance on their account. In order to attend any events, play sports and enjoy our amenities, you must pay your assessments. If you have questions regarding your delinquent balance, please feel free to call the HOA office 770-919-2556 for more details.

Two lucky residents will be randomly selected to receive \$332.50 back in dues at the meeting! To qualify, you must have used Buildium for a payment and 2021 dues must have been already paid in full.

### **REVISED POLICY FOR MAY CLUBHOUSE RENTALS**



Due to Covid and the amount of interest in May Clubhouse Reservations, we are making a change **ONLY FOR THE MONTH OF MAY.** 

Starting February 1st, Clubhouse reservations will open for **ALL MAY DATE**S, without a 90 day restriction. To comply with the Executive Order, gatherings are limited to 50 maximum.

**PLEASE CHECK** to make sure the date/time you are requesting is available prior to sending in the following:

- Reservation Form
- COVID Waiver
- Payment

Existing Reservations can be checked at www.legacypark.org under Activities. The calendar shows available dates.

Please include your first option and an alternate option in case someone completes their request prior to yours.

Be sure to include BOTH the Clubhouse Rental Agreement and COVID Waiver. Payment may be made through your online Buildium Portal. If you prefer to fill it out in person and drop payment off, please email clubhouse@legacypark.org to make an appointment (or call 770-919-2556).

Reservations are not confirmed until the paperwork and payment is received. A confirmation email indicates you have the date/time you selected.

Please do not drop the forms in the dropbox as we have no way to determine which ones were received first.
